Dear Dr. Hewett:

It is a pleasure to inform you that Brookhaven Science Associates (BSA) at the Department of Energy (DOE) Brookhaven National Laboratory (BNL) has successfully completed the DOE Earned Value Management System (EVMS) Acceptance Review process. As a result of the independent surveillance review conducted and the corrective actions taken thus far by BSA-BNL, it has been determined that the EVMS continues to meet the requirements of Electronic Industries Alliance (EIA)-748.

To verify EVMS compliance, an independent surveillance/EVMS acceptance review was conducted on August 15-17, 2023. The three-day virtual surveillance review was hosted by the Brookhaven National Laboratory (BNL).

During the review, the surveillance committee identified four Corrective Action Requests (CARs) and eleven Continuous Improvement Opportunities (CIO/CIO*). CIO*s are not strict requirements but would improve the EVMS system and require a corrective action plan.
